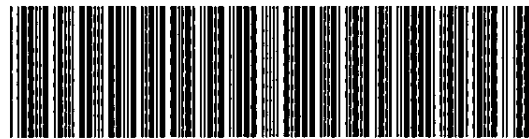



ARTICLE I. NAME

The name of this corporation is M. A. K. OF BREVARD, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.




