#### STATE OF FLORIDA ARTICLES OF INCORPORATION OF

In Style Hair Boutique, Inc.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I
