**ARTICLES OF INCORPORATION

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation under the Florida Business Corporation Act, Chapter 607, Florida Statutes, for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name and initial address of this Corporation shall be: MAINSTREET N40, INC., 2101 West Commercial Boulevard, Suite 1200, Fort Lauderdale, Florida 33309, with the privilege of having its offices and branch offices at other places within or outside the State of Florida.


ARTICLE X


