

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CREDIT SUITE INC.

Credit Suite Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

- 1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on June 26, 2014, as amended by that certain Articles of Amendment filed on June 21, 2014 and that certain Articles of Amendment filed on January 19, 2016 (collectively, the "Articles of Incorporation").
- 2. Pursuant to Section 607.1003, Florida Statutes, this amendment to the Articles of Incorporation was approved by unanimous written consent of the shareholders of the Corporation as of December 12, 2022. This amendment was approved by unanimous written consent of the board of directors of the Corporation as of December 12, 2022.
- 3. These Articles of Amendment to the Articles of Incorporation shall be effective immediately upon filing by the Secretary of State of the State of Florida (the" <u>Effective Date</u>"), and thereafter.
- 4. Article II of the Article of Incorporation of the Corporation shall be deleted in its entirety and replaced with the following:

5. Article IV of the Articles of Incorporation of the Corporation shall be deleted in its entirety and replaced with the following:

"The number of shares the Corporation is authorized to issue is 1,000,000 shares of Common Stock."
