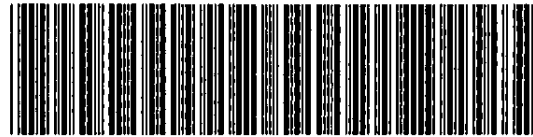

THE UNDERSIGNED subscriber, a natural person competent to contract, acting as incorporator of corporation (hereinafter referred to as the "Corporation") under the provisions of the statutes of the State of Florida, does hereby make, subscribe, acknowledge and file the following Articles of Incorporation:

ARTICLE 1

Purpose: The Corporation may engage in any activity or business permitted under the laws of the United States and of Florida. It will engage in the wholesale, distribution and import/export of steel and other metals.
