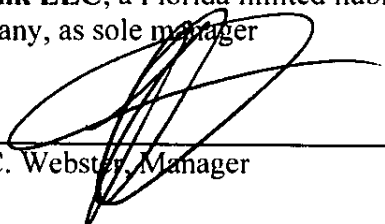

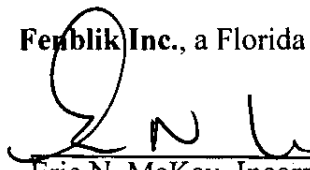

**ARTICLES OF INCORPORATION
OF
FENBLIK INC.**

ARTICLE I: Name

The name of the Corporation is "Fenblik Inc."

ARTICLE II: Principal Office and Mailing Address

The Corporation shall maintain its principal office and mailing address at 637 1st Avenue N, Jacksonville Beach, Florida 32250.

ARTICLE III: Duration

The Corporation shall have perpetual existence

ARTICLE IV: Purpose

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act ("FBCA").

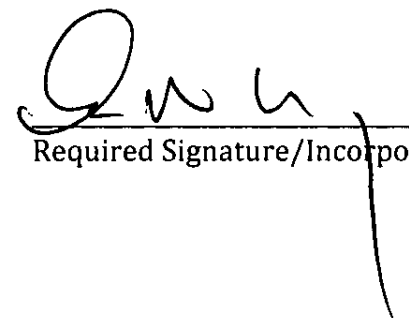
