ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this Corporation is RAMONA & JON'S HAIR SALON, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

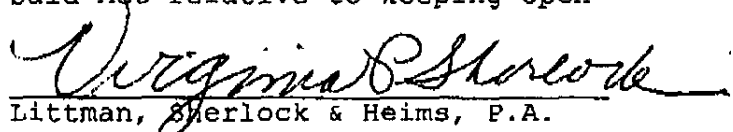
