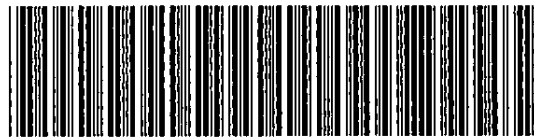

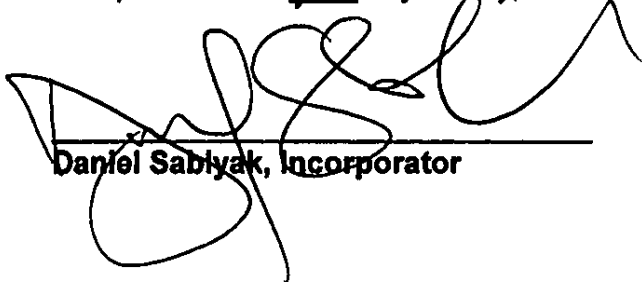
ARTICLE X - INDEMNIFICATION

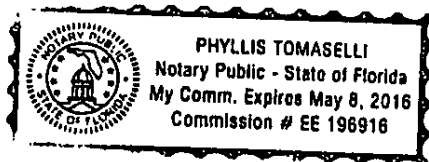
