ARTICLES OF INCORPORATION

OF

SOUTH FLORIDA BUSINESS BROKERS, INC

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE 1 - CORPORATE NAME

The name of this corporation is:

ARTICLE II - NATURE OF CORPORATE BUSINESS

The general nature of the business to be transacted by this corporation is as follows:

- (a) To operate a business to list, buy and sell all kinds of businesses, whether sole proprietorship, partnerships, or small or large corporations and the engaging in, of any other business incidental and pertinent thereto.
