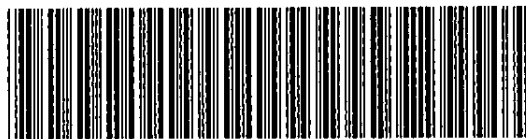

Name

Incorporator




