ARTICLES OF INCORPORATION  
OF  
ATLANTIC AMERICAN OPPORTUNITIES CORP.

The undersigned, acting as incorporator of Atlantic American Opportunities Corp. (the "Company") under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME AND ADDRESS

The name of the Company is: Atlantic American Opportunities Corp. The street address of the initial principal office and the mailing address of the Company is 101 E. Kennedy Blvd., Suite 3300, Tampa, Florida 33602.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the Company commences on July 8, 2014, unless the filing of these Articles of Incorporation occurs more than five (5) business days thereafter, in which event such existence commences on the date and at the time when these Articles of Incorporation are filed with the Florida Secretary of State.

ARTICLE III. DURATION OF EXISTENCE

ARTICLE IV. GENERAL PURPOSES

The general purposes for which the Company has been organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida and to carry out said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE V. CAPITAL STOCK

The total number of shares of all classes of stock which the Company shall have authority to issue is 1,000 shares of common stock having a par value of \$.01 per share (the "Common Stock").

ARTICLE IX. INDEMNIFICATION



Absent specific action by the board of directors, the authority granted to the board of directors in this paragraph (b) shall create no rights in the persons eligible for indemnification or advancement of expenses and shall create no obligations of the Company relating thereto.


