ARTICLES OF INCORPORATION OF NATHALIE STANIK-DURLET, P.A., a Florida Professional Association

The undersigned, Ilcensed or otherwise legally authorized to practice real estate sales by and within the State of Florida, hereby acting as incorporators for the purpose of forming a professional service corporation for profit, by virtue of the provisions of Chapters 621 and 607, Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE L - CORPORATE NAME

The name of the Corporation is NATHALIE STANIK-DURLET, P.A., a Florida Professional Association.

ARTICLE II. - CORPORATE DURATION

The duration of the Corporation is perpetual, and the Corporate existence is to commence upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III. - PURPOSE AND POWERS

The Corporation is organized for the following purposes:

- (a) To engage in every aspect of the practice of real estate sales and all of its fields of specialization as are engaged in by a real estate agent in this State.
- (b) To engage and render the professional service involved only through its officers, agents and employees who are licensed real estate agents in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the professional service of this Corporation.
