#### ARITCLES OF INCORPORATION

OF

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contact, do herby form a corporation for profit under the laws of the State of Florida.

#### ARTICLE I

#### <u>Name</u>

The name of this corporation is TOOLE'S TOTAL LAWN AND SHRUB CARE, INC.

#### ARTICLE II

#### **Business**

The general nature of this business of businesses to be transacted by this corporation is:

- (1) Residential real estate sales.
- (2) Open for any type of business the corporation deems to be profitable.

#### ARTICLE II

#### Capital Stock

The maximum number of shares of stock authorized to be issued by this corporation is 1,000 shares of capital stock of the par value of \$1.00 each, all of which shall have the same rights and privileges.

Each share of capital stock shall entitle the holder thereof to one vote at any stockholder's meeting and otherwise to participate in all such meeting and in the assets of the corporation. They shall be issued for such consideration as may be determined by the Board of Directors, which shall have a value at least equal to the full par value of such shares. No holders of shares of any class of stock, now or hereafter authorized, shall have any right as such to purchase, subscribe for or otherwise acquire from the corporation any shares of its stock of any class or any securities convertible into shares of its stock, or any warrants or rights to subscribe for or purchase shares of its stock, whether now or hereafter authorized, except such rights as the Board of Directors in its absolute discretion may grant to such holders.

#### ARTICLE IV

#### Initial Capital

The corporation shall begin business with a paid-in capital of One Thousand Dollars (\$1,000.00).

#### ARTICLE V

#### Existence

The corporation shall have perpetual existence unless dissolved according to law.

#### **ARTICLE VI**

#### Principal Office

The initial street address of the principal office of the corporation in this State will be 13342 Sylvan Avenue, Fort Myers, Florida 33919.
