Certificate of Incorporation of

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 1,500 of which 1,000 shares of par value \$0.01 per share shall be designated as Common Stock and 500 shares of par value \$0.01 shall be designated as Preferred Stock. Shares of Preferred Stock may be issued in one or more series from time to time by the board of directors, and the board of directors is expressly authorized to fix by resolution the voting powers, designations, preferences, limitations, restrictions, relative rights and distinguishing designations of each series of Preferred Stock before the issuance of any shares of Preferred Stock in such series.
