ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of JDR Express, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is: IDR Express, Inc.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS OF THE CORPORATION
