ARTICLES OF INCORPORATION OF CES ECHO INVESTMENTS, INC.

The undersigned, acting as incorporator of CES ECHO INVESTMENTS, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

<u>ARTICLE I. NAME</u>

The name of the corporation is CES ECHO INVESTMENTS, INC. (the "Corporation").
