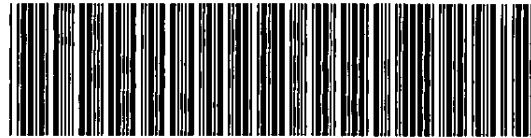

I, the under signed, being of legal age, do hereby subscribe to,, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be Juncal's Group, Inc. and initial address of this corporation shall be 14831 Harding Drive, Homestead, FL 33033.



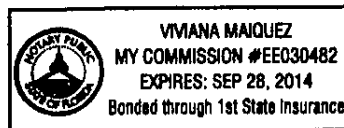
