

ARTICLE I. NAME

The name of this corporation shall be TOO'S INVESTMENTS, INC.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

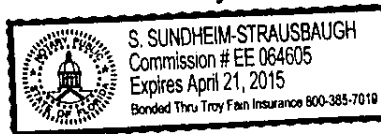
