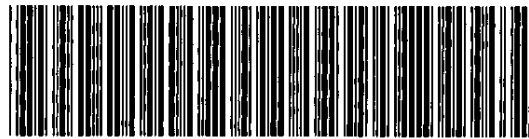

ARTICLES OF INCORPORATION

OF

AMC FREE CE ACADEMY, INC.

I.

The name of the corporation is "AMC FREE CE ACADEMY, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

III.

The corporations shall have perpetual duration.

IV.

The corporation is a corporation for profit organized for the following purposes.


