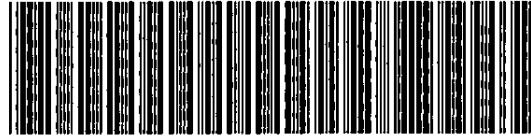

duties as may be prescribed by the Bylaws or as may be determined from time to time by the Board of Directors subject to the Bylaws.



This corporation reserves the right to amend, alter, change or repeal any provision contained herein in the manner now or hereafter prescribed by law, and all rights conferred on stockholders herein are granted subject to this reservation.


