**ARTICLES OF INCORPORATION
OF
PUCKERBRUSH FARMS INC.**

The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is PUCKERBRUSH FARMS, INC. (the "Corporation").

ARTICLE II

The street address of the initial principal office and mailing address of the Corporation is Suite 900, 200 S. Andrews Avenue, Fort Lauderdale, Florida 33301.

ARTICLE III

The maximum number of shares of stock which this Corporation is authorized to issue or to have outstanding at any time shall be 10,000 shares of common stock.

The Corporation expressly elects not to be governed by either Section 607.0901 of the Florida Statutes relating to affiliated transactions or Section 607.0902 of the Florida Statutes relating to control share acquisitions, as each may be amended from time to time.
