

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

## **ARTICLE I. NAME**

THE NAME OF THIS CORPORATION IS DENIM BLUE PUBLISHING, INC.

#### ARTICLE II. PRINCIPAL PLACE OF BUSINESS

THE PRINCIPAL PLACE OF BUSINESS OF THIS CORPORATION WILL BE 3493 KINGS ROAD #105, PALM HARBOR, FLORIDA 34685.
