

ARTICLES OF INCORPORATION OF TT OF TJ, INC. (a Florida corporation)

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of TT OF TJ, INC., a corporation being organized under the laws of the State of Florida.

ARTICLE I. Name
