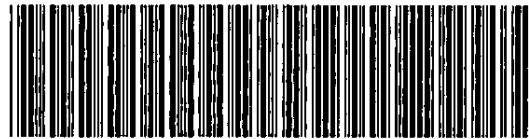



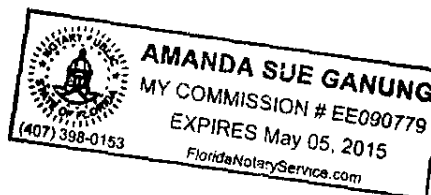
1. **Introduction.** Michael Tromble, being duly sworn, deposes and says:


