**ARTICLE I
Name**

Amendments

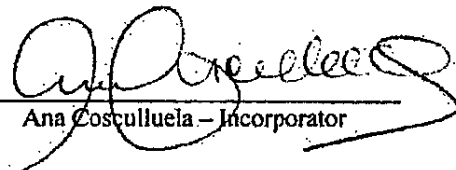
