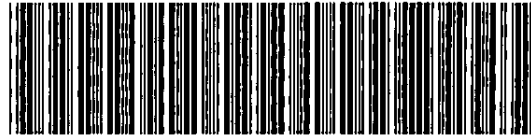

ARTICLES OF INCORPORATION

OF EFFECTIVE DATE 08/21/14

GAME CREEK ENTERPRISES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation

Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME





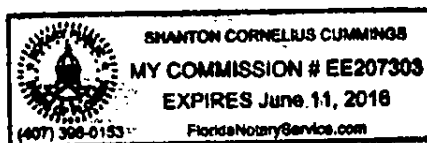
