The undersigned, for the purposes of incorporating a corporation under the Florida Business Corporation Act, does hereby execute these Articles of Incorporation and does hereby certify as follows:

FIRST: The name of the corporation (hereinafter called the "Corporation") is Video Ventures Inc. The principal place of business is 1401 Forum Way #730, West Palm Beach, Florida 33401.

SECOND: The address of the registered office of the Corporation in the State of Florida is 1401 Forum Way #730, West Palm Beach, Palm Beach County, Florida 33401, and the name of the registered agent at that address is Brian Albert.

<u>THIRD</u>: The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

<u>FOURTH</u>: The Corporation is authorized to issue one million (1,000,000) shares of Common Stock, par value \$0.001 per share.

<u>FIFTH</u>: The Corporation shall continue to exist perpetually.

Neither any amendment nor repeal of this Article EIGHTH, nor the adoption of any provision of these Articles of Incorporation inconsistent with this Article EIGHTH, shall eliminate or reduce the effect of this Article EIGHTH in respect of any matter occurring, or any cause of action, suit or claim that, but for this Article EIGHTH, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision.


