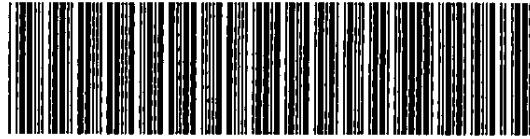

ARTICLES OF INCORPORATION

I, the undersigned, being of full age, do hereby subscribe for the purposes of forming and organizing a professional service corporation under the Chapter 621, Florida Statutes and other laws of the State of Florida, and hereby adopt and declare the following Articles of Incorporation covering the existence and organization of this corporation:

ARTICLE I

The name of the corporation shall be Arlene Bechtold, P.A.

ARTICLE II

This corporation is formed to engage in every phase and aspect of the practice of a real estate broker or salesperson as defined by Chapter 475, Florida Statutes. In addition, the corporation may invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE III

The maximum number of shares of stock authorized to be issued by this corporation shall be limited to one thousand (1,000) shares of common stock of the par value of \$1.00 per share, and each share of common stock shall entitle the holder thereof to one vote at any stockholders' meeting

and said common stock shall otherwise fully participate in all stockholders' meetings and in the assets of the corporation, and shall be fully paid and non-assessable. Said shares shall be paid for in lawful money of the United States of America or in property, labor or services at a just valuation to be fixed by the corporation or its Board of Directors.

None of the shares of this corporation may be issued to anyone other than an individual duly licensed as a real estate sales person, broker, or broker-sales person in the state of Florida.

ARTICLE IV

This corporation shall commence corporate existence on the date of this filing of these Articles with the Department of State and thereafter have perpetual existence, unless sooner dissolved by law.

ARTICLE V

The street address and mailing address of the corporation is 3155 S. Access Road, Englewood, Florida 34224, the name of the initial registered agent is Arlene Bechtold and the street address of the initial registered office of the corporation is 3155 S. Access Road, Englewood, Florida 34224.

ARTICLE VI

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the Bylaws. The name and address of the initial director of this corporation are:

ARTICLE VII

The corporation is authorized to issue only one class of stock. Stock shall be issued and transferable only to natural persons who are not nonresident aliens.

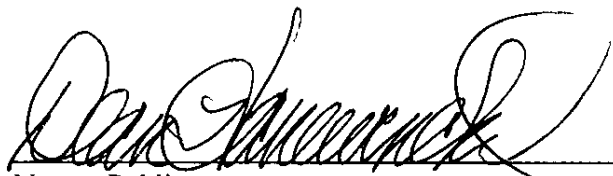

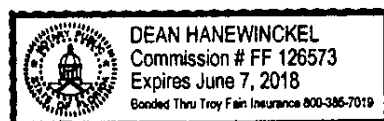
