ARTICLE XI: AMENDMENTS

These articles of Incorporation may be amended in a manner provided by law. Every amendment shall be proposed and approved by the officers of the Association.

ARTICLE XII: INDEMNIFICATION

The Association shall indemnify an officer of the Association who has wholly and successfully, on the merits or otherwise acted on behalf of the Association, in the defense of any proceeding to which the Officer is or was a party because the officer is or was an officer of the association against reasonable attorney fees or expenses incurred as a result of a direct connection with the proceeding. The Association may indemnify an individual made a party to a proceeding because the individual is or was an officer, employee or agent of the Association against liability authorized in the specific case after termination, in the manner required by the board of directors, so long as the indemnification of the officer, employee or agents, as the case may be, is the standard of conduct set forth by the Officers. The indemnification and advancement of attorney fees and expenses for officers, employees and agents of the Association, shall apply when such persons are serving or have served at the Association's request while an officer, employee or agent of the Association, as the case may be. The Association may also pay for or reimburse the reasonable attorney fees and expenses incurred by an officer, employee or agent of the Association who is a party to a proceeding in advance of final disposition of the proceeding. The Association may also purchase and maintain insurance on behalf of an individual arising from the individual's status as an officer, employee or agent of the Association, whether or not the Association would have power to indemnify the individual against the same liability under the law. All reference in these Article of Incorporation are deemed to include any amendment or successor thereto. Nothing contained in the Articles of Incorporation shall limit or preclude the exercise of any right to indemnification or advancement of attorney fees and expenses to any person who is or was an officer, employee or agent of the Association by contract or in any other manner. If any word, clause, or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees and expenses shall be held invalid as contrary to law or public policy, it shall be several and the provisions remaining shall not be otherwise affected. All references in these Articles of Incorporation to officer", "employee and "agent" shall include the heirs, estates, executors, administrators, and personal representatives of such persons.


