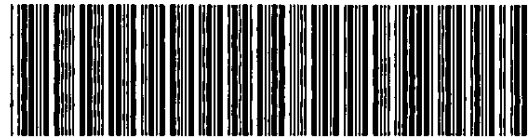

The undersigned, acting as an incorporator of Yet I Survived Dance Ministry & Studio, Inc. in compliance with Chapter 607 and /or Chapter 621 F.S (Profit) adopts the following Articles of Incorporation.

Articles I

Name

The name and address of this principle corporation is Yet I Survived Dance Ministry & Studio, Inc.

4302 Woodstock Drive # D West Palm Beach, 33409 in Palm Beach County.

The corporation is organized pursuant to the Florida Profit Corporation Code.

Articles II

Commencement of Existence

The duration of this corporation shall be perpetual. The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

Articles III

Purpose

To establish and operate a full service networking group under the name Yet I Survived Dance Ministry & Studio Inc. However this corporation may engage in any activities or business permitted under the laws of the United States and Florida.

Articles VI

Authorized Shares

The maximum number of shares that the corporation is authorized to have outstanding at any time is 100 shares of common stock having a per value or \$1.00 per share. 

Amendment

The corporation elects to have pre-emptive rights. All shareholders of the corporation are entitled to accumulate their votes for directors. No amendments shall be made to the Article when the shares voting against the proposal to amend be made would be sufficient to elect a director by voting and such shares are entitled to be voted cumulatively for the election of directors.
