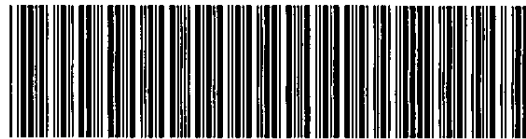

**ARTICLES OF INCORPORATION  
OF  
PENSACOLA SALVAGE AT MILTON, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be Pensacola Salvage at Milton, Inc.


**ARTICLE VII. DIRECTORS**
