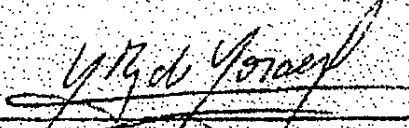

Indemnification

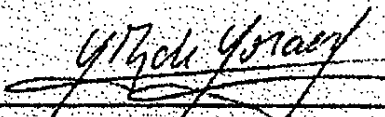
