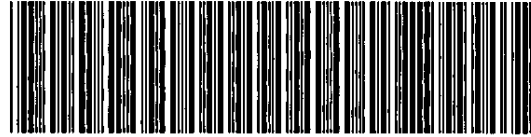

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF

(changing number of authorized shares)**

The following provisions of the Articles of Incorporation of **GAINESVILLE ADR, INC.**, a Florida professional association, filed in Tallahassee on September 19, 2014 and effective September 21, 2014, be and hereby are amended in the following particulars in order to increase the number of authorized shares from ONE HUNDRED to TEN MILLION:

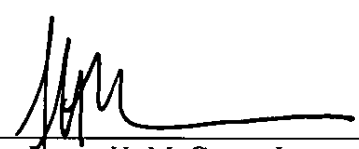
1. Article IV of the Articles of Incorporation are hereby amended to read as follows:

Such amendment shall be inserted and effective to replace the existing Article IV with the amended Article IV set forth above where it appears therein.

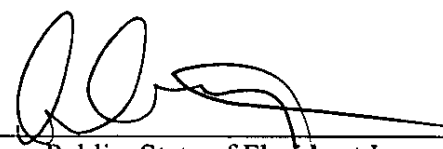
The foregoing amendment was adopted by the sole Stockholder and sole Director of the Corporation on the 2<sup>nd</sup> day of October, 2014.
