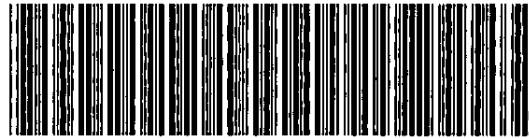

ARTICLE I. NAME

The name of this corporation is WILLA IMPORT & EXPORT CORP.

ARTICLE II. DURATION




