

# SECOND AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SLIDEX INC.



(Original Articles of Incorporation filed with the Secretary of State of the State of Florida on September 23, 2014)

Pursuant to Sections 607.1006 and 607.1007 of the Florida Business Corporation Act (the "Act") Slidex Inc., a corporation organized and existing under the laws of the State of Florida, hereby certifies as follows:

FIRST: The name of the corporation is Slidex Inc. (the "Corporation") and the Corporation was originally incorporated in the State of Florida on September 23, 2014, under the name "Flowin, USA, Inc.," the original articles were amended and restated on April 24, 2015 and these Second Articles of Incorporation amend, restate and supersede in their entirety the Corporation's Articles of Incorporation as amended to date and filed with the State of Florida.

SECOND: The Second Amended and Restated Articles have been approved by the shareholders of the Corporation in accordance with Section 607.1003, 607.1006 and 607.1007 of the Act on August 16, 2015.

## ARTICLE I NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of this corporation is SLIDEX INC. The street address of its initial principal office and its mailing address is 16051 Collins Avenue, 3702, Sunny Isles, Florida 33160.

## ARTICLE II NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

- a. To engage in any and all lawful business or activity permitted under the laws of the United States and the State of Florida.
- b. To generally have and exercise all powers, rights and privileges necessary and incident to carrying out properly the objects herein mentioned.
- c. To do anything and everything necessary, suitable, convenient or proper for the accomplishment of any of the purposes or the attainment of any or all of the objects herein before enumerated or incidental to the purposes and powers of the corporation or which at any time appear conductive thereto or expedient.

#### ARTICLE III TERM OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date on which the Articles of Incorporation were originally filed with the Secretary of State of the State of Florida.

#### ARTICLE IV CAPITAL STOCK

- A. This Corporation is authorized to issue two classes of shares of common stock to be designated "Class A Common Stock" and "Class B Common Stock". The total number of shares of common stock that this Corporation is authorized to issue is TWENTY SEVEN MILLION (27,000,000). FIFTEEN MILLION (15,000,000) of such shares shall be shares of Class A Common Stock. TWELVE MILLION (12,000,000) of such shares shall be shares of Class B Common Stock, with such other terms as the Directors may specify from time to time. Except as set forth in Article IV.B., the Class A Common Stock and the Class B Common Stock shall be identical in all respects and shall have equal rights and privileges.
- B. In any vote of the shareholders of the Corporation, each share of Class A Common Stock shall carry one (1) vote per share and each share of Class B Common Stock shall carry two (2) votes per share.
