ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
PELICAN WIRE COMPANY 2014

(FLORIDA DOCUMENT NO. P14000078872)

Pursuant to the provisions of Section 607.1006, Florida Statutes, PELICAN WIRE COMPANY 2014, a Florida corporation (the "Corporation"), hereby adopts the following amendment to the Corporation's Articles of Incorporation:

1. The name of the Corporation is Pelican Wire Company 2014.
2. Article I of the Corporation's Articles of Incorporation is hereby amended by deleting it in its entirety and inserting in lieu thereof the following:

"ARTICLE I
CORPORATE NAME"

"The name of the corporation shall be PELICAN WIRE COMPANY"

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
4. The amendment hereby made to the Articles of Incorporation was approved by the Corporation's sole shareholder by written consent on November 4th, 2015 which was sufficient for approval.
