The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the Corporation shall be IMPORTADORA BILLY 21 C.A., CORP.

PRINCIPAL OFFICE

PURPOSES

INSPECTION OF BOOKS AND RECORDS
