No shareholder of this corporation shall sell any shares of stock held by him or her in this corporation without first offering to sell such stock to the corporation on the same terms and conditions and at the price offered in good faith and in writing, by any proposed purchaser. The written offer such proposed purchaser shall be delivered to the corporation at the time the stock is offered to the corporation for sale.
