# ARTICLES OF INCORPORATION OF ANKEE CABINET SERVICES, INC.

THE UNDERSIGNED, natural person(s) of legal age, acting as incorporator(s) for the SEE, FLORIDA Purpose of forming a corporation under the laws of the State Florida adopt(s) the following Articles of Incorporation.

### **ARTICLE I - NAME**

The name of the corporation is ANKEE CABINET SERVICES, INC,

### ARTICLE II - DURATION

The period of its duration is perpetual.

## **ARTICLE III – PURPOSE (S)**

The purpose(s) for which the corporation is organized are "To operate a Commercial, Domestic and Industrial Cabinet Service Business, consisting sales, installation, repairs and any other service activities in the industry".
