CERTIFICATE OF ARTICLES OF INCORPORATION 4 007 -3 PM 3: 02

RAFSHAR INC.

I, the undersigned, hereby enter into this certificate of Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

ARTICLE I

NAME

The name of the corporation shall be RAFSHAR, INC.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is as follows:

- a. To create, design, manufacture, market and distribute sports and active wear, and all products appurtenant thereto nationally and internationally. To maintain facilities nationally and internationally to accomplish there objectives.
- b. To acquire by purchase, subscription or otherwise and to hold for the purpose of investment or otherwise, and to own, sell or otherwise dispose of and deal in stocks, bonds, mortgages, securities, notes, commercial papers, or otherwise deal with other evidence of debt, issued by any government, state, county or other public authority, or by any one or more persons, firms, corporations, or associations, either foreign or domestic, and whether now or hereafter organized, and while the owner thereof, to execute all of the rights, powers and privileges of ownership; to guarantee or become surety with respect to any obligations of said persons, firms, corporation, or associations contained in any of said securities.
- c. To purchase real estate and to build upon or in any manner improve any

real estate owned by it.

- d. To purchase, acquire, hold, sell, convey, mortgage, lease, exchange, and otherwise deal in real estate and property of every kind, nature and description whatsoever.
- e. To buy, sell, trade or deal in any kind of goods, services, wares and merchandise.
- f. To organize or cause to be organized under the laws of the State of Florida, or any other state, district, territory, province or government, a corporation or corporations for the purpose of accomplishing any and all objects for which this corporation is organized and to dissolve, windup, liquidate, merge or consolidate any such organization or corporation or to cause the same to be dissolved, wound up, liquidated, merged or consolidated.
- g. To purchase, hold, sell, exchange or transfer or otherwise deal in shares of its own capital stocks, bonds, or other obligations from time to time as to such an extent and in such a manner, and upon such terms as its Board of Directors shall determine, provided that this corporation shall not use any of its funds or property for the purchase of its own shares of capital stock when such would cause any impairment of the capital of the corporation, and provided further that shares of its own capital stock belonging to this corporation shall not be voted directly or indirectly.
- h. To engage in or conduct any lawful business permitted by the laws of the State of Florida by virtue of its corporate acts.

The foregoing clauses shall be construed both as objects and powers; and the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of the corporation and it is the intention that the purposes, objects, and powers specified in each of the paragraphs of Article II of the Certificate of Articles of Incorporation shall, except as otherwise specifically provided, in no way be limited under the terms of any other clauses, or paragraphs of this Article or any other Articles or paragraphs of this Article and shall be regarded as independent purposes, objects and powers.

ARTICLE III

AUTHORIZED SHARES

The amount of authorized capital stock of this corporation shall be 600 shares of common \$1.00 par value, voting stock, being all that are issued, to be fully paid and exempt from assessment.

ARTICLE IV

INITIAL CAPITALIZATION

The amount of capital with which this corporation shall begin business shall not be less than \$500.00

ARTICLE V

TERM OF EXISTENCE

The term for which this corporation shall exist is perpetual.

ARTICLE VI

PRINCIPAL OFFICE


