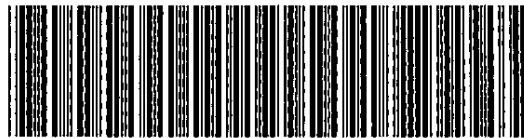

The Board of Directors may from time to time designate such other Address and place for the register or principal office of this Corporation, as it seems fit.




