## Capital Stock

- (a) The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 10,000 shares of common stock with a par value of \$.01 per share. - (c) In the election of directors of this corporation, there shall be no cumulative voting of the stock entitled to vote at such election.

## Existence of Corporation

This corporation shall have perpetual existence.

## ARTICLE 6

## Registered Office and Registered Agent

The initial registered office of this corporation shall be located at 10114 Downey Lane, Tampa, Florida 33626, and the initial registered agent of this corporation at such office shall be Nariman Niktash, M.D. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

# **Board of Directors**

The Board of Directors of this corporation shall consist of not less than one (1) nor more
