ARTICLES OF INCORPORATION

OF

BAKER CLARK HOMES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I-NAME

The name of this corporation is Baker CLark Homes, Inc.

ARTICLE II-DURATION

This corporation shall have a perpetual existence.
