**ARTICLE I
NAME OF CORPORATION**

The name of the corporation shall be: TMJ International, Inc. (the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE**

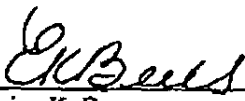
