ARTICLES OF INCORPORATION
OF
HJB Transport, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is: HJB Transport, Inc.

ARTICLE II

The existence of the Corporation shall begin on the date of filing.

ARTICLE III

The street address of the initial principal office of the Corporation is: 17 SE 24th Ave., Pompano Beach, FL 33062. The mailing address, if different, is: PO BOX 50332, Lighthouse Point, FL 33074.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one thousand, par value \$1.00 per share, all of which shall be Common Shares.
