Attachment to Certificate of Incorporation of PM2 Global Technologies Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 6,000 of which 3,000 shares of par value \$0.01 per share shall be designated as Common Stock and 3,000 shares of par value \$0.01 shall be designated as Preferred Stock.
