The total number of shares of all classes of stock which the Corporation shall have authority to issue is 3,000,000 of which 2,000,000 shares of par value \$0.00001 per share shall be designated as Common Stock and 1,000,000 shares of par value \$0.00001 shall be designated as Preferred Stock.
