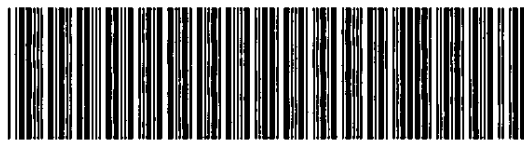

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I. NAME

THE NAME OF THIS CORPORATION IS **FIRST CHOICE INVESTIGATION AND CONSULTING, INC.**

ARTICLE II. PRINCIPAL PLACE OF BUSINESS
