ARTICLES OF INCORPORATION

OF

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purposes creating a corporation under the laws of the State of Florida.

ARTICLE I

The name and individual address of this Corporation shall be: Winship Law, P.A., 230 S. New York Avenue, Suite 200, Winter Park, Florida 32789, with the privilege of having its offices and branch offices at other places within or without the state of Florida.

ARTICLE II

The Corporation is organized for the purposes of engaging in the practice of law in the State of Florida and all its fields of specialization as engaged in by lawyers pursuant to Chapter 621 of the Florida Statutes. The Corporation shall engage and render the professional services involved only through its officers, agents, and employees who shall be in good standing, licenses or otherwise legally authorized within the State of Florida to render the same professional services as the Corporation.
