ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

ANCHOR PROPERTY AND CASUALTY INSURANCE COMPANY

Pursuant to Section 607.1006 of the Florida Business Corporation Act, Anchor Property and Casualty Insurance Company (the "Corporation") hereby adopts the following articles of amendment to its articles of incorporation.

- 1. The name of the Corporation is Anchor Property and Casualty Insurance Company.
- 2. Article 1 of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

ARTICLE 1 NAME

The name of the corporation shall be Patriot Select Property and Casualty Insurance Company. For convenience, the corporation shall be referred to in this instrument as the "Company". These Articles of Incorporation shall be referred to as the "Articles" and the Bylaws of the Company shall be referred to as the "Bylaws."

3. Article 2 of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

ARTICLE 2 OFFICE

The principal office and mailing address of the Company shall be 5999 Central Avenue, Suite 300, St. Petersburg, FL 33710 in Pinellas County or at such other place as may be subsequently designated by the Board of Directors. All books and records of the Company shall be kept at its principal office or at such other place as may be permitted by the Florida Insurance Code.

- The amendment was adopted on November 22, 2023.
- 4. This amendment was approved by written consent of the sole shareholder of the Corporation on November 22, 2023, which was a number of votes sufficient for approval.
